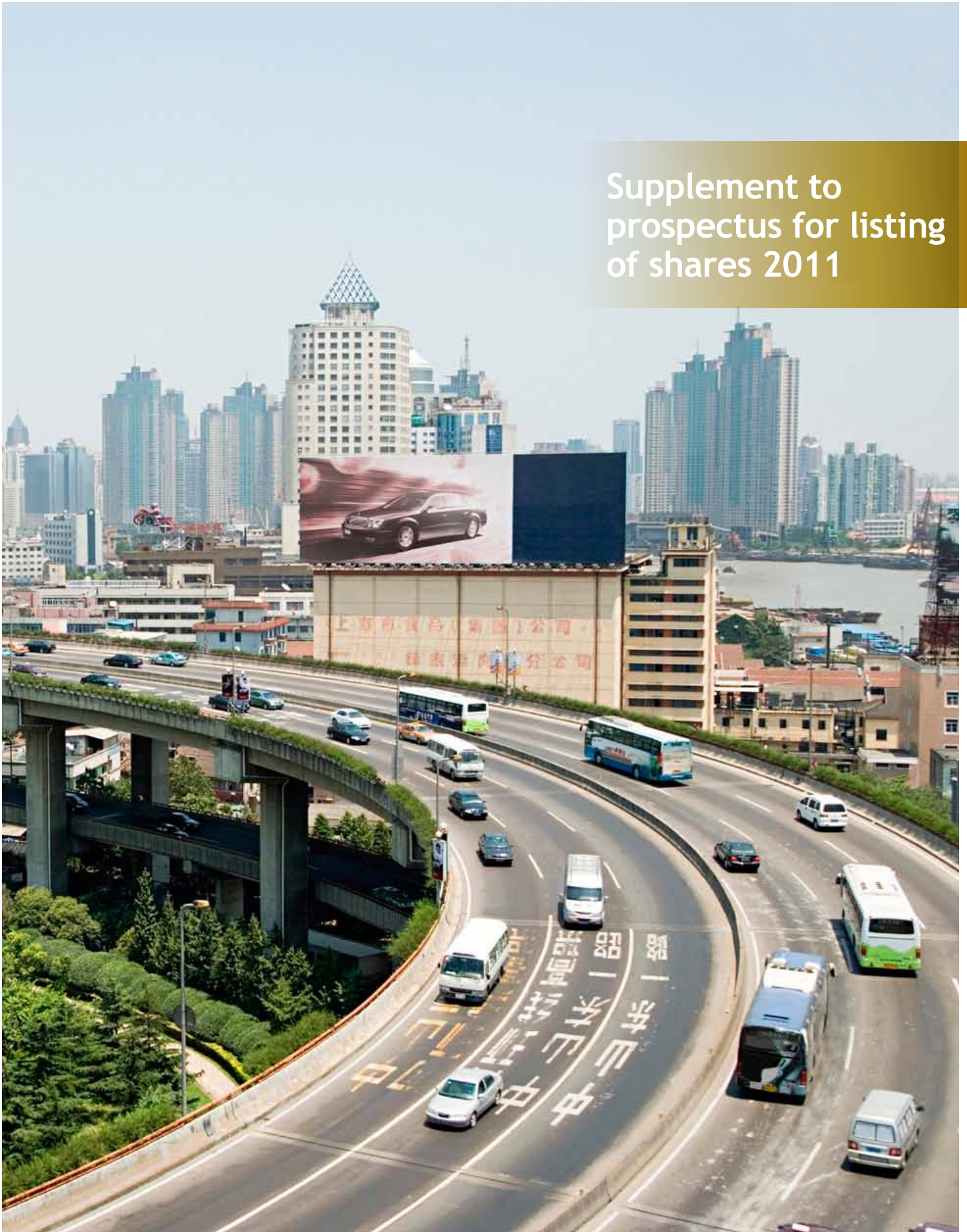


Supplement to

Supplementary information

This document is a supplement to the prospectus for listing of shares prepared by Concentric, approved by, and registered with, the Swedish Financial Supervisory Authority, (*Finansinspektionen*) (the “**SFSA**”) on May 23, 2011 (SFSA registration number: 11-4742). The prospectus was published on May 24, 2011.

This prospectus supplement has been prepared by reason of the announcement by Concentric and Haldex on

June 8, 2011 that David Woolley has been appointed new President and CEO of Concentric, effective August 1, 2011. The press release is included in its entirety in this prospectus supplement.

The prospectus supplement was approved by the SFSA on June 10, 2011 (SFSA registration number 11-6253) and published by Concentric on the same day.

This prospectus supplement has been prepared in view of the listing of the shares in Concentric AB (publ) (“**Concentric**”) on NASDAQ OMX Stockholm. The prospectus supplement does not contain and does not constitute an offer or invitation to acquire securities.

This prospectus supplement is governed by Swedish law. The courts of Sweden have exclusive jurisdiction to settle any dispute arising out of

or in connection with this prospectus supplement. This prospectus supplement has been prepared in Swedish and English language versions. In case of any inconsistency between the Swedish and the English versions of the prospectus supplement, the Swedish version shall prevail.

The shares in Concentric are not subject to any application for trading in any country other than Sweden. The shares in Concentric have not been, and will not be, registered under the United States Securities Act of 1933 or the securities laws of any state or other jurisdiction outside Sweden. This prospectus supplement may not be distributed in any jurisdiction where such distribution would require any additional prospectus, registration or measures other than those required under Swedish law, or otherwise would conflict with regulations in such jurisdiction.
